

## **Solar Photovoltaic Power Generation Transfer Contract**

What is a solar power purchase agreement (PPA)?

A solar power purchase agreement (PPA) is a financial contractin which a third-party developer owns, operates, and maintains the photovoltic system, and a customer agrees to purchase the system's electric output from the solar services provider for an agreed-upon price and for a predetermined period.

#### How does a solar agreement transfer work?

The seller submits a request to initiate the solar agreement transfer with the buyer, including escrow details. The assuming party is contacted to review the obligations of the agreement and address any other questions. The transfer agreement is sent to both the assuming party and the seller for signatures via AdobeSign.

#### What are standardised solar contracts?

Standardised contracts include: Power Purchase Agreement, Implementation Agreement, O&M Agreement, Supply Agreement, Installation Agreement and Finance Facility Term Sheet. These are complemented by the Implementation Guidelines. Open Solar Contracts review phase is now over.

#### Do solar projects need an EPC contract?

In our experience,most utility-scale solar projects use an EPC Contract. An operation and maintenance agreement: This is usually a medium- to long-term Operating and Maintenance Agreement (O&M Agreement) with an Operator. The term of the O&M Agreement will vary from project to project.

#### What is a PV installation agreement?

The Installation Agreement is a lump-sum agreement between the project company, as owner of the project, and the installation contractor, the contractor that will be responsible for installing the PV system, providing the balance of plant and commissioning the plant.
